S&P 500 INDEX – Measures the performance of large capitalization U.S. Stocks. The S&P 500 is a market-value-weighted index of 500 stocks that are traded on the NYSE, AMEX and NASDAQ. The weightings make each company's influence on the Index performance directly proportional to that company's market value.

RUSSELL 1000 GROWTH INDEX – Measures the performance of those Russell 1000 companies with higher price-to-book ratios and higher forecasted growth values.

RUSSELL 1000 VALUE INDEX – Measures the performance of those Russell 1000 companies with lower price-to-book ratios and lower forecasted growth values.

MSCI EMERGING MARKETS FREE INDEX – A market-capitalization-weighted index made up of equities from 26 developing countries.

RUSSELL 2000 VALUE INDEX – Contains those Russell 2000 securities with a below-average growth orientation. Securities in this index generally have lower price-to-book and price-to-earnings ratios than those in the Russell 2000 Growth Index.

RUSSELL 2000 GROWTH INDEX – Contains those Russell 2000 securities with an above-average growth orientation. Securities in this index generally have higher price-to-book and price-to-earnings ratios than those in the Russell 2000 Value Index.

MSCI EAFE – A Morgan Stanley Capital International index that is designed to measure the performance of the developed stock markets of Europe, Australia, and the Far East.

LB AGGREGATE BOND – The Lehman Brothers Aggregate Bond index. This index includes U.S. government, corporate and mortgage-backed securities with maturities up to 30 years.

CITIGROUP NON-U.S. DOLLAR WORLD GOVERNMENT BOND INDEX (FORMERLY SALOMON BROTHERS) – An index that includes institutionally traded bonds other than U.S. issues that have a fixed rate and a remaining maturity of 1 year or longer.
